

He has translated several Arabic novels into English and was one of the translators for Writing Revolution: The Voices from Tunis to Damascus (LB Tauris, 2013) which won the 2013 English PEN Award for outstanding writing in translation. His translations of Yasser Abdellatif's The Law of Inheritance and Iman Mersal's How to Mend: Motherhood and its Ghosts are due to be published later this year.

Yasser Abdel Hafez is an Egyptian novelist and journalist, born in Cairo in 1969. A law graduate from Ain Shams University, Cairo, he began his career as a journalist when he was 18, and has worked on Cairo's Akhbar al-Adab weekly literary journal since

its inception. Excerpts from his first novel *On the Occasion of Life*, published in 2005, appeared in Banipal 25 – New Writing in Egypt, in Spring 2006. *Kitab al-Aman*, his second work now translated as *The Book of Safety*, this year's Saif Ghobash Banipal Prize winner, was published in 2013.

The Banipal Trust for Arab Literature was founded in 2004 by the publisher of Banipal magazine. It supports and promotes cultural dialogue between the Arab world and the West, the translation into English and publication of works by contemporary Arab authors, and the production of live literature events with Arab authors in the UK. 

The Goethe-Institut Award, presented since 2010, is a biennial award of €1,000 for the best translation from a chosen text – this year from *Unterleuten* by Juli Zeh. The winner is invited to attend the Leipzing Book Fair, which includes a place at the International Translators' meeting.





Mandy Wight was born in Bangor, Wales and brought up in Reading and then York. After living and working as a solicitor in London for ten years, she moved back north to Sheffield in 1986 where she re-trained as a teacher and brought up her family. She now lives in the Hope Valley, Derbyshire. She came to translating through being a linguist and a reader in German and French mostly, as well as English, but had put translation on hold until she left her last teaching post in 2014. She subsequently attended seminars at the Literary Translation Centre at the London Book Fair, and the Translate in the City course, run by the City of London University. She has had translation published online with No Man's Land and in 2017 attended the Summer School at BCLT. She has written reader's reports for the magazine New Books

in German and her blog on books, including German books, is peakreads.wordpress.com.



The Schlegel-Tieck Prize (£3,000) has been awarded annually since 1965 and takes its name from two great poets of the Romantic period, August William Schlegel (1767-1845) and his friend Ludwig Tieck (1773-1853), also a noted translator.





Allan Blunden is a British translator who specialises in German literature. He is best known for his translation of Erhard Eppler's *The Return of the State?* which was the runner-up for the 2010 Schlegel-Tieck Prize. He has also translated biographies of Martin Heidegger and Stefan Zweig, and the prison diary of Hans Fallada.

Hans Fallada (1893–1947) was the pen name of German author Rudolf Ditzen, whose books were international bestsellers. He opted to stay in Germany when the Nazis came to power, and eventually had a nervous breakdown when he was put under pressure to write anti-Semitic books. He was confined in a Nazi insane asylum, where he secretly wrote The Drinker. Immediately after the war he wrote his last two novels. Nightmare in Berlin and Alone in Berlin, but he died before either book could be published.

THE SCOTT MONCRIEFF PRIZE FOR TRANSLATION FROM THE FRENCH

Winners: Will McMorran and Thomas Wynn for their translation of *The 120* Days of Sodom by the Marquis de Sade (Penguin Classics)



The **Marquis de Sade** was born in Paris in 1740 and spent 32 years of his life in prison and insane asylums for a host of violent and sexual crimes. He wrote *The 120 Days of Sodom* while incarcerated in the Bastille. He was accepted by a new regime after the French Revolution, but by 1796 was a ruined man. He died in an insane asylum in 1814.



The Premio Valle Inclán of £2,000 was first awarded in 1997 and is given annually.





Margaret Juli Costa has been a literary translator for over thirty years. She has been commended for the Premio Valle Inclán five times, and won the prize three times, twice for translations of novels by Javier Marías. She won the 2017 Best Translated Book Award for her co-translation with Robin Patterson of the Brazilian novelist Lúcio Cardoso's Chronicle of the Murdered House, A Fellow of the Royal Society of Literature, she has been awarded an OBE for services to literature, and in 2015 she was given an Honorary Doctorate by the University of Leeds.

Rafael Chirbes (1949–2015) wrote nine novels and received the National Prize for Literature and the Critics Prize for *On the Edge*. ABC named him 'the best writer of the twenty-first century in Spain'.

David McKay was born in the United States and has lived in The Hague since 1997. He is a translator of both fiction and non-fiction, especially in the field of the visual arts, and academic work. Together with translator Ina Rilke he recently put the finishing touches to an English translation of Max Havelaar or the coffee auctions of the Dutch trading company by Multatuli, which will be published in 2018 by NYRB Classics in New York. He is now working on a translation of the novel De bekeerlinge by Stefan Hertmans.

Stefan Hertmans is the prizewinning author of many literary works, including poetry, novels, essays, plays, short stories and a handbook on the history of art. He has taught at the Royal Academy of Fine Arts in Ghent, at the Sorbonne, the Universities of Vienna, Berlin and Mexico City, at The Library of Congress in Washington, and University College London.

The Dutch Foundation for Literature promotes interest in Dutch-language literature abroad. It maintains contacts with a large number of international publishers, and has a stand at major international book fairs in Frankfurt, London, Bologna and Beijing. Foreign publishers wishing to publish translations of Dutch or Friesian literature may apply for a subsidy towards the translation costs. (letterenfonds.nl/en)

The TA First Translation Prize, newly established in 2017, is an annual £2,000 prize for a debut literary translation into English published in the UK. The prize is shared between the translator and the book's editor.





Bela Shayevich is a Soviet-American artist and translator. She studied Comparative Literature at Emory University and received a Masters in Russian translation from Columbia University.

Jacques Testard is the founder and editor of Fitzcarraldo Editions. Testard was previously commissioning editor at Notting Hill Editions and cofounded arts and literature journal the White Review.

Svetlana Alexievich was born in Ukraine in 1948 and has spent most of her life in the Soviet Union and present-day Belarus, with prolonged periods of exile in Western Europe. Starting out as a journalist, she developed her own non-fiction genre, bringing together a chorus of voices describing specific historical moments. Her works include The Unwomanly Face of War

(1985), Zinky Boys (1990), Chernobyl Prayer (1997) and Second-hand Time (2013). She was awarded the Nobel Prize for Literature in 2015.
